Trump Administration an Accomplice in Access to Preborn Child Murder Pills

There are many right and just efforts and accomplishments of President Donald J. Trump and his administration for which I am immensely grateful. When the Creator GOD first delegated some of His authority to mankind to establish civil government and gave His Law, doing “righteousness and justice,” and protecting human life were and remain paramount to Him (Genesis 9:5-6; Exodus 20:13; 21:22-23; Deuteronomy 16:18-20; Psalm 89:14). Because President Trump is working so hard to honor GOD, do “righteousness and justice,” and protect human life, it is incomprehensible to many of us why he is not enforcing the 1873 Comstock Act. That Act prohibits the mailing of anything that can cause an abortion. By being unwilling to enforce the Comstock Act, by permitting millions of abortifacient pills – rightly called “murder pills” by Tony Perkins – to be sent through the mail, President Trump and his Administration are accomplices in the murder of hundreds of thousands of babies.



Yesterday, Tony Perkins, President of Family Research Council, interviewed Dr. Robert George, McCormick Professor of Jurisprudence at Princeton University, on the [Washington Watch program](#) for July 16, 2026. If you cannot watch and listen to the entire hour program, I encourage you to start at the 38 minute mark, just before the interview with Dr. George.

Tony Perkins reported what happened during the nomination hearing for Acting Attorney General Todd Blanche. Senator Ted Cruz directly asked General Blanche: “Will you commit that the Department (of Justice) will carefully evaluate every lawful action available to ensure the faithful enforcement of the Comstock Act and other Federal pro-life acts?” Blanche responded: “Yes!”

Perkins summarized what the Biden Administration did after the U.S. Supreme Court *Dobbs* decision, overturning the *Roe* decision, in 2022: “the Biden Administration made an all of government effort to try to find a way to keep abortion” widely available. So they chose (1) not to enforce the Comstock Act, and (2) loosened the requirements for dispensing mifepristone, the chemical abortion drug, allowing it to be easily distributed without medical supervision.

Dr. George replied, “I don’t understand why the Trump Administration has adopted the posture it has adopted here. It makes no sense. It’s certainly not legal. In fact, it frustrates the intent of the law. It is very discouraging to me to see a Republican Administration on the wrong side of this. . . . Our concern is with the use of the drug to kill unborn babies. The Trump Administration is simply on the wrong side of this issue.”

Dr. George continued: “The states have the authority to restrict or prohibit abortion, but if they don’t, pursuant to its authority under the 14th Amendment, the Federal Government, our National Government, has the authority to step in and prevent elective abortion. This is not a states rights issue.”

Perkins responded: “But . . . the states are now being prohibited from doing what . . . they have a right to do. States are not able to protect the unborn and the women in their states because of this drug coming in through the mail without medical oversight, and they can’t stop it.”

Dr. George responded: “So no matter what laws are enacted (by individual states), through the use of Telehealth and mail order (drugs), the pro-life laws of the states can be completely frustrated. So the people that are claiming this is a matter for the states are not permitting the states to take jurisdiction of the matter.”

Perkins added: “The abortion rates have gone up since the overturn of *Roe*. We’ve seen about a 20 percent increase in the number of abortions . . . primarily, if not solely, because of this drug mifepristone . . . coming into mailboxes. . . . Planned Parenthood has shifted their business model to more of an Amazon model through the abortion pill. . . . The mailbox and the mail is now the main delivery (mechanism) in this country.”

Dr. George added: “The majority of abortions are now done by chemical abortifacients like mifepristone . . . That means women go through all that at home, often without medical supervision, actually delivering the dead embryo, and having to dispose of the dead embryo. It is a complete nightmare.”

Perkins added: “Men are going online and ordering this drug, putting it into the drink or food of their girlfriend or in some cases their wife to kill their unborn child.”

Dr. George replied: “Like everything about the abortion license, it is a license serving the interest of predatory men, men who do not want to take responsibility for their actions.”

Perkins observed: “The Federal Government has become a facilitator of this, an accomplice!”

Dr. George affirmed: “An accomplice, an accomplice! The Federal Government being a Republican Administration that has claimed to be pro-life.”

Dr. George added: “A central concern I have is that the Republican Party, on the orders of President Trump, removed – and you worked so hard to prevent this from happening, and I congratulate you – removed the pro-life commitment from the Party’s Platform. The pro-life plank of the Platform was summarily removed without even any serious debate. . . . We need to get that plank back in the Platform. This Party has got to be brought back to its fundamental pro-life convictions, and they have to be stated.”

PRAY that President Trump and his Administration would immediately recognize their duty to GOD and to American citizens to protect human life from conception or fertilization to natural death, to do only “righteousness and justice,” to immediately enforce the Comstock Act and stop murder pills from being sent by mail or other delivery means, and to punish those who are violating just laws.
